## MINUTES OF EXTRAORDINARY PARISH COUNCIL MEETING Held at 7.30pm on 18 October 2023 at Astley Village Hall

#### 52.23 Apologies for Absence

Apologies were received from Councillor K Sumner.

#### 53.23 Disclosable Pecuniary Interests

- a) No disclosable pecuniary interests were declared
- b) There were no applications for a dispensation regarding disclosable pecuniary interests

#### 54.23 Appointment of Clerk and Responsible Financial Officer

It was proposed by Councillor Lloyd and seconded by Councillor Mardell and

#### resolved (without opposition)

that Lisa Harris be appointed as the Clerk and Responsible Financial Officer to Astley Parish Council.

#### 55.23 Public Participation Session

Mr Stuart Thomas of Berrys gave a brief overview of planning application 23/04120/FUL explaining how he believed that the reasons for refusal of application 22/03512/FUL had now been addressed. The Chairman permitted an extended public participation period of 45 minutes to allow parishioners sufficient time to express their views on the proposal and to ask questions of Mr Thomas and Condover College. Concerns raised centred around the themes of road safety (both on the A53 and the lane running through Bings Heath), the open countryside designation of the area, increased risk of flooding, and the fact that the proposed development would be of no community benefit. As an aside, Bings Heath residents reported difficulties in communicating with Greenfields following incidents at the current facility. Mrs Vikki Pryce (Chief Executive of Condover College) advised that it is best to contact the head office on 01743 872250 during business hours.

After full consideration, it was put to a vote to determine whether Astley Parish Council would support, object or remain neutral on the planning application. In representing the views of the Parish, all five councillors present, voted to object.

It was proposed by Councillor Mardell and seconded by Councillor Robinson and

that Astley Parish Council would lodge an objection with Shropshire Council in respect of planning application 23/04120/FUL.
