5. UPDATE

5.1 Update from Shropshire Councillor Lezley Picton

- an email regarding a recent accident in Astley on the A53, which involved a lorry, had been received from a concerned regular commuter, the email had been forwarded to Shropshire Council traffic engineers (Highways).
- Shropshire Council staff recruitment -there is a national shortage of planners
- Boundary Review The Boundary Commission is going to do a Divisional Review so Shropshire Council may not now do a Parish Council Review.
- SC pedestrian scheme in Shrewsbury has now stopped, it will recommence at the end of October on Saturdays and Sundays
- SC budget for the next financial year is now being worked on, 85% of the controllable budget is spent on 3% of the Shropshire population.

5.2 Update from RAF Shawbury

Gliding was discussed. It was decided that parish councillors would monitor gliding activity over the next few months and feed back to Shawbury RAF with any evidence if flying when not meant to be or route not being changed.

6. OFFICIAL AND PARISH MATTERS

6.1 Co-option of New Councillor(s)

Since the application that was received earlier this year in July, an application had been received from a different parishioner, Helen Mardell. Ms Mardell's application was considered and following discussion, Members were unanimous in their decision that Ms Mardell be co-opted to the Parish Council.

RESOLVED: That Helen Mardell be co-opted to Astley Parish Council.

- shortlist and interview applicants
- recommend successful applicant to Parish Council for recruitment.

6.4 PLANT A TREE FOR THE QUEEN'S JUBILEE

A lengthy discussion took place, mainly around thoughts of finding a location that would be suitable to plant a tree, also maintenance of such. One Member highlighted that there was no public green space in the area.

RESOLVED: After careful consideration Members resolved not to plant a tree as it would not be practical.
