1. OPEN FORUM

There was one member of the public in attendance. The Parish Council welcomed Maria Prinold, who had expressed an interest in becoming a parish councillor.

2. APOLOGIES

3. **DECLARATION OF INTEREST** Declaration of any disclosable pecuniary interest in a matter to be discussed at the meeting, and which is not included in the Register of Interests. 4. MINUTES

The minutes of the meetings held on 16 May 2018 were approved and signed as a true record.

5. **RAF Shawbury UPDATE**

Acting Sgt Paul Humphreys is now the representative for the RAF base, having recently returned from an overseas placement. A list of RAF activity at the base was circulated. Families day is 3 August, and tickets may be available for parish councillors and local families. Acting Sgt Humphreys will attend the July meeting of the Council and provide a number of tickets. There was a discussion about possible visits to the base to look at the new building. The new vicar may also be interested in visiting Shawbury. A litter pick may be organised for late summer around the village areas, but not on the main roads.

6. OFFICIAL AND PARISH MATTERS

6.1 Defibrilator: Cllr Lloyd reported that the defibrillator and lockable cabinet have been ordered as agreed. There is also a need for a minimal electricity supply to provide a 5 amp electric supply to the box outside the village hall. Clerk to write to Maryon White and ask that she informs the Village Hall Committee of this development and request permission for an electrician to visit and install the wire. A survey of 150 village halls has revealed that the increased use of electricity is so small that it has made no discernible difference to the electricity bills.

7. PROGRESS REPORT

7.1 Parish Councillor Vacancy: Following the advertisement of the vacancy there was no call for an election and the parish council is therefore asked to co-opt a new member. Maria Prinold spoke at the meeting to express her interest in being co-opted. It was agreed that this be on the agenda for the July meeting of the parish council, with a view to making a formal co-option on that date.
